24 HOUR NOTIFICATION IS REQUIRED TO SCHEDULE ANY INSPECTION. ANY CONTRACTOR FOUND NOT TO HAVE CALLED FOR PROPER INSPECTIONS, MAY BE REQUIRED TO REMOVE BUILDING MATERIALS THAT HINDER THE BUILDING DEPARTMENT FROM DOING ANY INSPECTION. THIS WILL BE AT CONTRACTORS EXPENSE. WORK SHALL NOT BE SCHEDULED TO OCCUR AFTER HOURS, WEEKENDS OR HOLIDAYS. SEE BUILDING PERMIT CARD FOR LISTING OF REQUIRED INSPECTIONS. CALL FOR UTILITY LOCATES PRIOR TO DIGGING.
